Assumption of Risk, Waiver of CLAIMS, Release OF LIABILITY and Indemnity Agreement.

ASSUMPTION OF RISKS: The parent of legal guardian of the Camper is aware that the Camper's participation in Rocker Girl Camp (which includes games, performances, dancing, singing, playing musical instruments and other similar activities) may include risks such as injuries caused during physical activities connected to onstage performances, rehearsals, and the use of musical instruments. THE PARENTS OF LEGAL GUARDIAN OF THE CAMPER FREELY ACCEPTS AND FULLY ASSUMES ALL SUCH RISKS, DANGERS AND HAZARDS ASSOCIATED WITH THE CAMPER'S PARTICIPATION IN ROCKER GIRL CAMP AND THE POSSIBILITY OF PERSONAL INJURY, DEATH, PROPERTY DAMAGE OR LOSS RESULTING THERE FROM.

WAIVER OF CLAIMS, RELEASE OF LIABILITY AND INDEMNITY AGREEMENT: FOR AND IN CONSIDERATION OF PERMITTING the Camper to join the Rocker Girl Camp, and participate in the activities and games, performances, dancing, singing, playing musical instruments and other such activities, the parent and legal guardian of the Camper HEREBY AGREES TO:

- (1) WAIVE ANY AND ALL CLAIMS the Camper, their parent/guardian or their respective personal representatives, assigns, heirs, and next of kin, have or may in the future have against ROCKER GIRL CAMP and each of its directors, officers, agents, and employees (all for the purposes herein referred to as "Releasees");
- (2) RELEASE THE RELEASEES from any and all damages, expense, injury, or death of Camper, or the Camper's next of kin may suffer as a result of the Camper's participation in the Rocker Girl Camp FOR ANY AND ALL LOSS OR DAMAGE, AND ANY CLAIM OR DEMANDS THEREFOR ON ACCOUNT OF INJURY TO THE PERSON OR PROPERTY, OR RESULTING OF DEATH OF CAMPER ARISING OUT OF, OR RELATING TO ROCKER GIRL CAMP, WHETHER CAUSED BY THE NEGLIGENCE(WHETHER SIMPLE OR GROSS) OF THE RELEASEES OR OTHERWISE, and

(3) To HOLD HARMLESS AND INDEMNIFY THE RELEASEES from any and all liability for any property damage or personal injury to the third party as a result of the Camper's participation in Rocker Girl Camp.

Each parent/guardian is responsible for ensuring that the Camper is dropped off at the main office area of Rocker Girl Camp located at 10330-84 Ave, Edmonton, Alberta, no earlier than 10am and picked up no later than 5:15 pm during each day of Rocker Girl Camp excluding first day registration which starts at 9:30 am.

The Releasees are not responsible for caring for the Camper outside of the scheduled camp times and are not responsible for any Camper that leaves the premises without specific written consent from the Camper's parent/guardian. **The Rocker Girl Camp shall at all times do its utmost to create and sustain a safe and friendly environment for each Camper to learn.**

We, the undersigned parents or legal guardians of the Camper, for and in consideration of our minor child's participation in the Rocker Girl Camp state that we **HAVE READ THIS RELEASE FORM, FULLY UNDERSTAND ITS TERMS, UNDERSTAND THAT WE HAVE GIVEN UP ESSENTIAL LEGAL RIGHTS BY SIGNING IT, AND HAVE FREELY AND VOLUNTARILY WITHOUT ANY INDUCEMENT, ASSURANCE OR GUARANTEE BEING MADE** and we expressly agree that the terms and conditions of said waiver, release and indemnifications will apply to and be binding upon us and our minor child in so far as it pertains to her participation in the Rocker Girl Camp and to any injury or damage our minor child may sustain or cause as a result of such participation. We understand that we are not required by law to sign this release form, that our child is permitted to participate in the Rocker Girl Camp only because we have agreed to sign it, and that the Releasees are relying on us signing it in allowing our child to participate in the Rocker Girl Camp.
